Rapid Fire Football Toss Contest
10/05/18 OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

All federal, state and local regulations apply.

1. DATES/CONTEST COMPONENTS:

These rules govern the Lady Jane's Haircuts for Men Contest (the "Contest") being conducted by KKFN (the "Station"). The Contest will begin on Monday, October 8, 2018 at approximately 12:00am MDT and will end on Saturday, October 20, 2018 at approximately 1:00pm MDT.

2. ELIGIBILITY

The Contest is open to all legal U.S. residents who are 18 years of age or older and who reside in the Denver Metro Area. Employees, officers, directors, and agents of Lady Jane's Haircuts for Men, the Station, the Station's licensee, Bonneville International, dba Bonneville Denver, KKFN, their parent, subsidiary, and affiliated companies, their advertising or promotional agencies, and any other participating sponsors (collectively, "Promotion Entities"), other radio stations in the Denver metropolitan area, the members of their immediate families and those living in the same household of each (whether related or not), are ineligible to enter or win. "Immediate family" members include spouses, children, step-children, parents, step-parents, siblings and step-siblings. No groups, clubs, or organizations may participate in this Contest. This Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited. any participating promotional companies and prize providers, their respective parents, affiliated and subsidiary companies, advertising and promotional agencies, web masters and web suppliers, and entities involved in the creation of Promotion materials, and members of the immediate family (spouse, children, siblings, parents) or persons living in the same household (whether or not related) of such employees, officers and directors are not eligible. Groups, clubs, organizations, commercial entities, and businesses cannot participate.

The following classes of people are ineligible to participate:

- i. Current or former professional or semi-professional football players;
- ii. Current or former high school or collegiate football players who have competed at that level within the past six (6) years;

- iii. Current football coaches who are coaching at the high school level or higher. By participating, you agree to these Official Rules and to all decisions of Sponsor, which are final and binding in all respects.

By participating, you agree to these Official Rules and to all decisions of Sponsor, which are final and binding in all respects.

- a. Proof of age, identity and eligibility must be furnished to Station upon request. All entry information must be complete and accurate. The Station will not award a prize to anyone not meeting eligibility requirements at the time of entry.
- b. Entrants are required to provide truthful information, and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements. The Station will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. HOW TO ENTER

- a. To participate in the Contest, you may enter via the following methods:
 - i. **On-Line Entry:** To enter on-line, visit www.1043thefan.com and follow the links and instructions to enter the Contest and submit your first name and last name, zip code, telephone number, date of birth, gender and a valid email address. Only one (1) entry per person is permitted. An entrant may use only one (1) email address for purposes of entry in this Contest. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address, and all multiple entries from the same email address shall be disqualified. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. Online entry webpage computer is the official time keeping device for the Contest. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems.
 - ii. **On-Site Entry:** To enter on-site, visit Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134 between 11:00am MDT and 11:59am MDT on Saturday, October 20, 2018 and complete an official entry form (available while supplies last) with your first name and last name, telephone number and age, and put the completed entry form in the registration box. Only one (1) entry per person is permitted.

All on-line entries must be received by Tuesday, October 16, 2018 at 11:59pm MDT. All on-site entries must be received by Saturday, October 20, 2018 at 11:59am MDT. The Station is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.

b. The winner may be required to provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize.

4. PARTICIPATING IN THE GRAND PRIZE EVENT

a. There will be two forms of qualifier selection:

- i. **On-Line Qualifier:** Twenty-five (25) on-line qualifiers will be pulled from all eligible on-line entries received on Tuesday, October 16, 2018. These on-line qualifiers will be asked to appear in person at the Grand Prize Event between 11:00am MDT and 11:59am MDT on Saturday, October 20, 2018 at Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134. If an on-line qualifier does not appear at Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134 by 11:59PM MDT on Saturday, October 20, 2018 they will be disqualified from the competition.
- ii. **On-Site Qualifier:** Twenty-five (25) on-site qualifiers will be pulled from all eligible on-site entries receive between 11:00am MDT and 11:59am MDT on Saturday, October 20, 2018 at Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134. Must be present in order to be selected as a qualifier.
- iii. There will be a maximum of fifty (50) qualifiers for the grand prize event. If all on-line qualifiers do not appear by 11:59pm MDT on October 20, 2018 at Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134, the Station will pull additional on-site qualifiers to get up to a total of fifty (50) qualifiers.

b. **Grand Prize Event Reverse Lottery:** The Grand Prize Event Reverse Lottery will begin at 12:00 PM MDT on Saturday, October 20, 2018 at Lady Janes Haircuts for Men at 19420 E. Lincoln Avenue, Suite 110 Parker, CO 80134. All qualifier names will be placed into the Grand Prize drum. If a qualifier's name is pulled out of the drum they are eliminated from the competition and will not be able to participate in the grand prize football toss. The Station will continue eliminating qualifiers until one (1) qualifier is left remaining. That one (1) qualifier will be deemed the contestant to compete in the grand prize football toss.

c. **Grand Prize Football Toss:** Contestant must attempt to throw as many NFL regulation footballs through the target hole in the target template as possible within the specified time limit. The specified time limit is 30 seconds. Limit one attempt per Contestant. Another person may hand footballs to the Contestant. A Successful Toss occurs only when a football thrown by a Contestant during the specified time limit passes completely through the target hole in the target template without coming into contact with anyone or anything (other than the template itself)

from the moment it is release by the Contestant until the time it passes completely through the target hole. The Contestant must be at least 15 yards from the target hole when he/she releases the football. Contestant(s) win prizes based on the number of Successful Tosses by the Contestant during the specified time limit as follows: No Contestant may win more than one prize.

Number of Successful Tosses Prize

10 or more = Grand Prize

Only 9 = First Prize

Only 8 = Second Prize

7 or less = No Prize

5. PRIZE(S)

a. PRIZE/ODDS/LIMITS ON PRIZES AVAILABLE: One (1) Grand Prize: \$25,000.00 (Twenty-Five Thousand Dollars and Zero Cents) - Limit One (1) Grand Prizes available. (2) First Prize: \$10,000 (Ten Thousand Dollars and Zero Cents) - Limit One (1) First Prizes available. (3) Second Prize: \$5,000.00 (Five Thousand Dollars and Zero Cents) - Limit One (1) Second Prizes available. The odds of being selected as a Contestant depend on the number of eligible entries received. The odds of a Contestant winning any available prize are dependent upon outside factors, including the skill of the Contestant, and are not subject to determination by traditional statistical means. Prize are not transferable and may not be given, bartered, sold, or exchanged for another prize. If no Contestant succeeds in making enough Successful Tosses, no prize will be awarded.

b. Winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize. The prize is awarded as is, and the Promotion Entities have neither made nor are responsible in any manner for any warranties, representations, or guarantees, express or implied, in fact or law, relating to the prize, with the exception of any standard manufacturer's warranty that may apply to the prize.

6. CONTESTANT SELECTION, NOTIFICATION AND CLAIM

a. Decisions of the Station management with respect to the Contest are final.

b. At 12:30pm MDT on Saturday, October 20, 2018, one (1) Contestant will be selected to have an opportunity to play to win the Grand Prize.

c. Participants must be present at Lady Janes Haircuts for Men at 19420 E. Lincoln Ave. Suite 110, Parker, CO 80134 at 12:00pm MDT on Saturday, October 20, 2018 in order to be selected to play to win the Grand Prize.

d. The contestant must execute and return any required affidavit of eligibility and/or liability/publicity release within fourteen (14) days of notification of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit

of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize and an alternate prize winner will be selected. Unless otherwise permitted by the Station, winner(s) must claim his or her prize in person, and a prize cannot be claimed by third parties on behalf of the winner. A parent or legal guardian must accompany any minor children in all Promotion-related activities, and a parent or legal guardian must claim the prize and sign any requisite releases on behalf of the minor child.

8. CONDITIONS AND LIMITATION OF LIABILITY

a. Entrants and participants are responsible for complying with all applicable federal, state, and local laws and regulations and with these Contest Rules, and by entering, participants agree to be bound to these official rules. The laws of the State or Commonwealth in which the Station is licensed shall govern this Contest, without regard to that jurisdiction's choice of law rules.

b. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other commonly owned stations in the Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent upon request will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

c. By entering the Contest, entrants and participants grant to the Promotion Entities the right to publicize the participant's name, photograph, video, image, likeness, voice, statements, and biographical information for advertising, trade, and promotion purposes without compensation and without opportunity for review, except where prohibited by law.

d. WINNERS AND ENTRANTS AGREE, EXCEPT WHERE PROHIBITED BY LAW, TO RELEASE AND DISCHARGE, HOLD HARMLESS AND INDEMNIFY THE PROMOTION ENTITIES, THEIR EMPLOYEES, AGENTS AND REPRESENTATIVES, OFFICERS AND DIRECTORS AND THEIR IMMEDIATE FAMILIES, SUCCESSORS AND ASSIGNS, AND ALL OTHERS ASSOCIATED WITH THE DEVELOPMENT AND EXECUTION OF THIS CONTEST, FROM ANY AND ALL TAX LIABILITY THAT MAY BE IMPOSED OR ASSOCIATED WITH RECEIPT OR USE OF THE PRIZES, AND FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, PROCEEDINGS, AND LIABILITY FOR ANY DAMAGES, EXPENSES, FEES, INJURY OR LOSSES (INCLUDING PERSONAL INJURY OR DEATH) SUSTAINED IN CONNECTION WITH THE RECEIPT, OWNERSHIP, OR USE OF THE PRIZE OR WHILE TRAVELING TO, PREPARING FOR, OR PARTICIPATING IN ANY PROMOTION-RELATED OR PRIZE-RELATED ACTIVITY.

a. b. If for any reason this Contest cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Contest, or if the Contest is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Contest. If the Contest is terminated before the original end date, the Station reserves the right to select the winners by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winners.

c. The Station, in its sole discretion, reserves the right to disqualify any person not abiding by the official rules, or for tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

d. The Station reserves the right to make changes in the rules of the Contest, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Contest and shall not be required to award a substitute prize.
